Therefore, it has been decided by the President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM) to Grant Conditional Permission for Intake capacity with 60 seats in UG (BAMS) Course under section 28 of NCISM Act, 2020 for the academic session 2022-23 and issuance of Letter of Permission (LOP) to the Principal, Anandi Shikshan Prasarak Mandal'S Ayurved Medical College, Hospital & Research Institute, Dhad Naka Area, Maharashtra (AYU0326) for increase intake capacity in existing UG (BAMS) course from 60 to 100 seats from the academic session 2022-23 under section 29 of NCISM Act 2020 and relevant regulations thereunder, subject to following conditions:
